

## SEPTEMBER 6, 2005 ALGANSEE TOWNSHIP

**ON TUESDAY, SETEMBER 6, 2005 at 7:30 p.m. the ALGANSEE TOWNSHIP BOARD** met at the Algansee Township Hall, 378 South Ray Quincy Road, Quincy, Michigan. Members present were Supervisor Erica Ewers, Treasurer Ann Strong, Trustee Bill Avra, Trustee John Shilling and Clerk Suzanne Preston. Visitors present that signed in were Dallas & Beverly Snyder, and Joy Wood.

**A. CALL MEETING TO ORDER/PLEDGE ALLEGIANCE-** Supervisor Erica Ewers called the meeting to order and Suzanne Preston led us in the pledge to the American flag.

**B. AGENDA ADDITIONS/DELETIONS-** Suzanne Preston motioned to accept the agenda as presented. Support by Ann Strong. Motion carried.

**E. 1. **E. 2. Audit/Quick Books Update-** Supervisor Erica Ewers said the auditor will be here at our September meeting. Suzanne Preston motioned to have the auditor give our Treasurer Ann Strong the quick books training. Support by Bill Avra. Motion carried.

**E. 3. IRS Update-** Treasurer Ann Strong said we haven't heard anything yet.

**F. 1. Fire Association-** John Shilling motioned to accept the Quincy Fire Association Agreement. Support by Bill Avra. Motion carried.

**F. 2. Planning and Zoning Commission Report-** John Shilling reported they are working on amending the Algansee Township Zoning Ordinance.

**H. 1. PLANNING COMMISSION MINUTES-** Bill Avra motioned to accept the August 29, 2005 Algansee Township Planning and Zoning Commission Minutes as presented. Support by John Shilling. Motion carried. Supervisor Erica Ewers reported we had a mix up with our bill from McKenna; she wrote them a letter and got it straightened out.

ANY OTHER NEW BUSINESS-** Jr. Carpenter had questions about the quality of dust control on Hammon Road; he was also upset with being connected with the gravel pit incident, in which he doesn't have anything to do with the gravel pit. Supervisor Erica Ewers reported that on Wolf Road, even with it being so dry there are 2 wet spots on Wolf Road that the Branch County Road Commission will look into. We all agreed to hold the payment to the Road Commission for Wolf Road until those wet spots are fixed.
